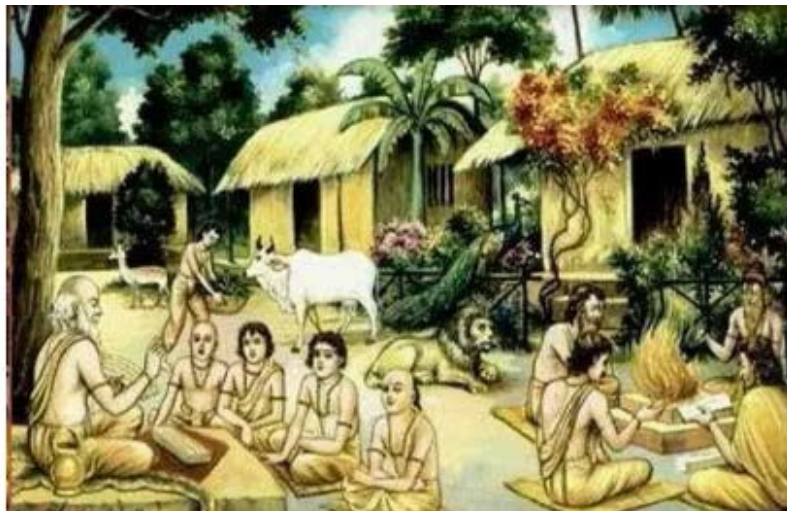

Preservation of Ancient Wisdom

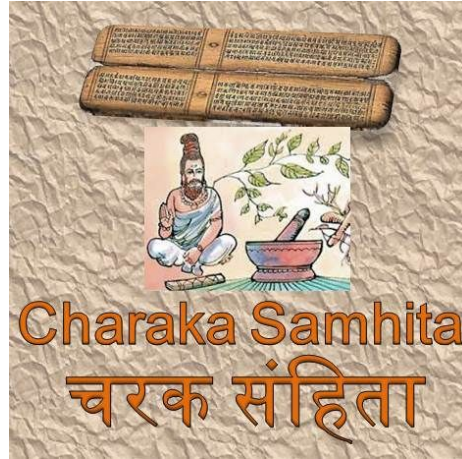

Influential Texts

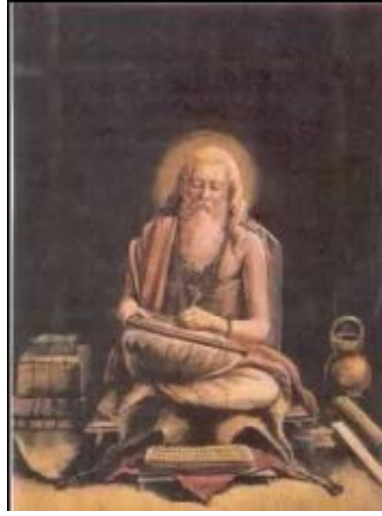
